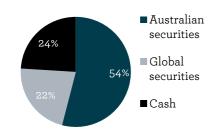

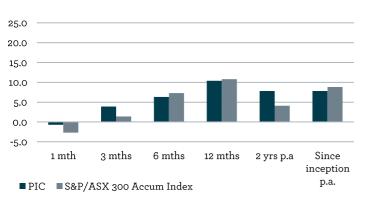

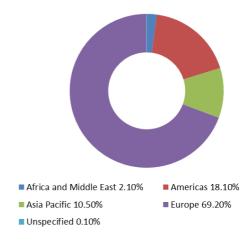
PORTFOLIO COMMENTARY

The Portfolio performance, as measured by the growth in net assets per share, was -0.7% in May. The portfolio outperformed the benchmark S&P/ASX300, which fell by -2.7%. Since listing, the Perpetual Equity Investment Company Limited's (PIC) portfolio has returned 7.8% per annum.

During the month, global stocks such as Deutsche Boerse, Icon PLC and Henderson Group PLC were the strongest contributors to performance. The Australian banking sector experienced a large decline in May but since PIC does not own CBA, ANZ or NAB and has only a small position in Westpac (2.2%), this assisted PIC's relative performance. Over recent months, the Manager has been increasing the exposure to global companies, particularly high quality, attractively priced companies in Europe.

An example of a recent European addition to the portfolio is AXA SA (FR:CS). AXA is a large international insurance company based in France but with operations around the world. It generates a little over half its earnings from life insurance, one-third from non-life insurance and the rest from asset management and banking.

Even though AXA has been significantly impacted by low interest rates post the global financial crisis, in the Manager's opinion AXA is a well-run and conservative company and it has been progressively moving towards writing business that is less market sensitive, such as protection (for example life insurance) and health. The Manager believes that this focus will mean that the business can grow, without being dependent on interest rates changing significantly.

Whilst AXA will never likely grow earnings much more than 4–7%, the Manager thinks they can achieve this level predictably over time. Combined with a dividend yield of over 5%, the Manager believes that AXA will deliver a reasonable return in an expensive market. In addition, AXA is planning to list a minority stake in their US life business, the proceeds of which are likely to be reinvested into other, faster growing parts of the business. As at 31 May 2017, AXA was 4.2% of the portfolio.

MARKET REVIEW

The Australian equity market, as measured by the S&P/ASX 300 Accumulation Index, posted a loss over the month in both absolute terms and relative to its global peers, as it ended the month 2.7% lower. The decline was driven by a large sell off in the banking sector, down 11.5%, due to a combination of a proposed bank levy handed down in the Federal budget earlier in the month, an unconvincing reporting season, and the credit rating downgrade by S&P to 23 of the non-major banks over heightened concerns of an impending housing bubble correction. The Discretionary Retail sector similarly caused a drag on market performance with several retailer bankruptcies and continued uncertainty over the disruption that Amazon may bring to the sector.

Global markets generally performed well as the MSCI World Total Return Index rose 2.6% in Australian dollar terms. The S&P 500 ended the month on a new high as an exceptionally strong earnings season in the US helped shrug off a mid-month slump following continued political upheaval in the Trump administration. This spurred a selloff in the US dollar and contributed to a significant spike in market volatility. Confidence in Europe rose early in the month with the victory of Emmanuel Macron as new French President, which also saw a strong rally in the Euro. Resilient earnings in the UK supported the FTSE 100, while weaker economic data and concerns over the upcoming election took its toll on the pound. The Australian dollar ended slightly down against most major currencies despite a persistent fall in iron ore prices as stockpiles continued to mount in Chinese ports. The Chinese sovereign debt rating was downgraded a notch to A1 from Aa3 by Moody's, while the outlook for Australia's AAA credit rating still "remains negative".

The best performing sectors for the month were Industrials (+4.7%), Telecommunication Services (+3.4%) and Energy (+1.5%). The worst performers were Financials ex Property (-7.7%), Healthcare (-2.4%) and Real Estate (-0.8%). As a whole, industrial stocks (-3.5%) underperformed resource stocks (+1.1%) and large cap stocks (-3.3%) underperformed small cap stocks (-2.1%).
